PiezoDrive Pty Ltd declares under its own responsibility that the product families listed above are compliant with the RoHS Directive (EU Directive 2002/95/EC and subsequent amendments). That is, the substances restricted by the EU Directive 2011/65/EU (RoHS2) and EU Directive 2015/863/EU (RoHS3) and subsequent amendments of the European Parliament are not contained in a finished product above threshold limits stated below, except at trace level due to unintentional impurities.
